Confirmed surcharges for the period 1.1.2018-31.12.2018:

Total charge

27 m² €141.75 / week / share 37 m² €194.25 / week / share Restaurant €182.75 / week.

Furthermore, the general meeting members authorised the Board to collect an additional fee no greater than the equivalent of one week's surcharge for the period of 2017. In addition, the general meeting members authorised the Board to collect an additional fee no greater than 460,000.00 euro for reserve funds. The additional surcharge will be collected only if the financing from the bank is not sufficient to finance the ongoing renovations.

The general meeting members authorised, by common consent, the Board and the CEO to negotiate, subscribe and withdraw a bank loan of 2.3 million euros from Sallan ja Käylän Osuuspankki. The payment period for the loan is until the end of 2025.

At the meeting, it was decided that collection of the surcharge for financial costs would begin at the start of 2017.

Surcharge for financial costs

27 m² €117.58 / week / share 37 m² €161.12 / week / share

The 2017 surcharge for financial costs will cover the 2016 deficit and repay the loan including the 1,800,000.00 euro loan already withdrawn as well as the 500,000.00 euro additional loan to be withdrawn.

At the meeting, it was decided that the surcharges for financial costs for 2018 are:

27 m² €102.98 / week / share 37 m² €141.13 / week / share

The surcharge for financial costs will be paid only for nine years as it was not collected for the first year though the loan was paid off.



The general meeting also approved the amendment to Articles of Association §16 and the change of 22§ to §23.

Other:

If you take pets along on your holiday, the cleaners will carry out a more thorough cleaning in the lodgings when you leave, for which we will charge you a €35 pet cleaning fee. If we are not informed about a pet, the cleaning company will charge us a larger cleaning fee, which we must pay in full. So please, inform us when you check in if you have a pet with you.
